Major Works at Glarus Court - External, Internal decorations and Sprinkler Installation (project AF106) - Invitation to residents meeting

We are pleased to inform you about our upcoming project for Glarus Court, which is known as Major Works. These are planned works such as repairs or renovations to the inside and outside and communal parts of the buildings.

What works are you proposing?

- External repairs include masonry repairs, wash down of all soffits and facias, cleaning
 of facades including the grills, render and concrete repairs, localised cleaning of prefinished render where stained and renewing all sash windows, replacing broken
 ironmongery, rubber seals and blown glazed units where required.
- Internal works include decoration and repairs, replacement of carpets on all storeys, all corridors and communal areas adhering to the same colour scheme.
- To install a new retrofitted in-flat sprinkler system to all 20 sheltered housing units and communal areas apart from the loft and service cupboards. A survey confirmed that there is adequate space high level to install a sprinkler pipework system concealed in decorative boxing around the perimeter of each dwelling.

Who is doing the work?

At the start of 2018, we entered a ten-year partnering contract with two contractors to deliver major works across the City. The contractor appointed to deliver the works is **United Living**.

When will the works start?

The project is at the first stage of the preparatory works, and we do not have exact dates. we would expect United Living to be ready to start these works in summer 2025.

We will write to update you at each stage, hold meetings and publish the relevant documents on our website for your information.

There are several stages that need to happen before the works start, including formal consultation with leaseholders via a Section 20 Notice of Estimate.
