

Ventilation works: The duct cleaning to the communal corridors has now been completed. In-flat works will start in March and you will receive a letter in the coming weeks to let you know how to book your appointment.





Ceiling and Decoration works: We are having discussions with the Residents' Association about ceiling materials and will hopefully have an update for you in the next newsletter.

Hide Tower

Front Entrance Doors: If your new front entrance door has not been installed, please call Denise to book your appointment. The essential remedial works and certification of the new front entrance doors continues, please book your appointment as soon as possible.



Ventilation works: The communal duct work has been cleaned and the in-flat works will start in March/April. You will receive a letter in the coming weeks to let you know how to book your appointment.

Communal Doors: A decision on style and material is yet to be agreed. We will hopefully have an update soon.

Dalkeith Court

You will see operatives carrying out minor decoration works throughout the block.

We are currently utilising scaffold to inspect holes in the ceiling for fire dampers and control valves.

The ventilation works will start soon and Denise will make contact with residents to book appointments.

Brunswick Court

The operatives are now going through the building touching up existing paintwork following the making good works.

A scaffold tower will be erected above cross corridor doors to enable the ventilation team to access the ducting.

Denise will be making contact regarding an appointment to fit the internal grills, where required.

We will be making appointments to complete the installation of any outstanding doors and any making good that is required.

We are anticipating the completion any outstanding snagging works by the end of February / mid March. Denise will be contacting residents shortly to book these works in.
