Works Update

Brunswick Court, Dalkeith Court and Hide Tower: The installation of the front entrance doors are almost complete.

With the communal doors almost finished (three remaining in Brunswick Court). These should be completed in August, including the high level screen over the corridor doors in Brunswick Court.

The remaining front entrance doors for Brunswick and Hide Tower will be delivered to site, late August 2021. We will of course keep you updated and call you once these have been delivered, in order to make an Installation appointment with you.

Semley House: The Installation of the front and rear entrance doors commenced in June 2021. Approximately 40% are now installed with the remainder due to arrive, on site during the month of August 2021. As soon as these arrive, we will contact you in order to make an Installation appointment.

Floor and Ceiling surveys are ongoing in readiness for works to start later in the year. We will keep you updated.

Ventilation Works: We understand that it may have been a little frustrating for you, that we have not been able to relay a start date for these works.

The designs have been reviewed by an independent Mechanical and Electrical Consultant and are now being reviewed by WCC.

Thank you for your patience during this time and we hope to update you soon, if not before our next newsletter.
