TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER 1963, 1966

WHEREAS the Lord Mayor Aldermen and Citizens of the City of Westminster acting by the Lord Mayor Aldermen and Councillors of the City of Westminster (hereinafter called "the Council") being the local planning authority for the City of Westminster are satisfied that it is expedient in relation to an area of land known as Nos. 1-47 (odd) and Nos. 2-56 (even) Abbey Gardens N.W.8. in the City of Westminster (hereinafter called "the said area") that any development of the description set out in the Schedule hereto should not be carried out in the said area on the said land unless permission therefor is granted on an application made in that behalf under the Town and Country Planning General Development Order 1963.

NOW THEREFORE the Council in pursuance of the powers conferred on it by Article 4(1)(a) of the Town and Country Planning General Development Order 1963 (hereinafter called "the said Order") and all other powers enabling hereby directs that the permission granted by paragraph (1) of Article 3 of the said Order and the First Schedule thereto shall not apply to development in the said area of the description set out on the Schedule hereto.

THE SCHEDULE referred to

Development within the curtilage of a dwelling house and sundry minor operations (being development comprised within the provisions of Classes I and II referred to in Part I of the First Schedule to the said Order and not

- (a) affecting the external appearance of any part facing a street (including any part not visible from street level) or
 - (b) carried out in front of any such part
- of any building situate in the said area but excluding the painting of the doors of such buildings.

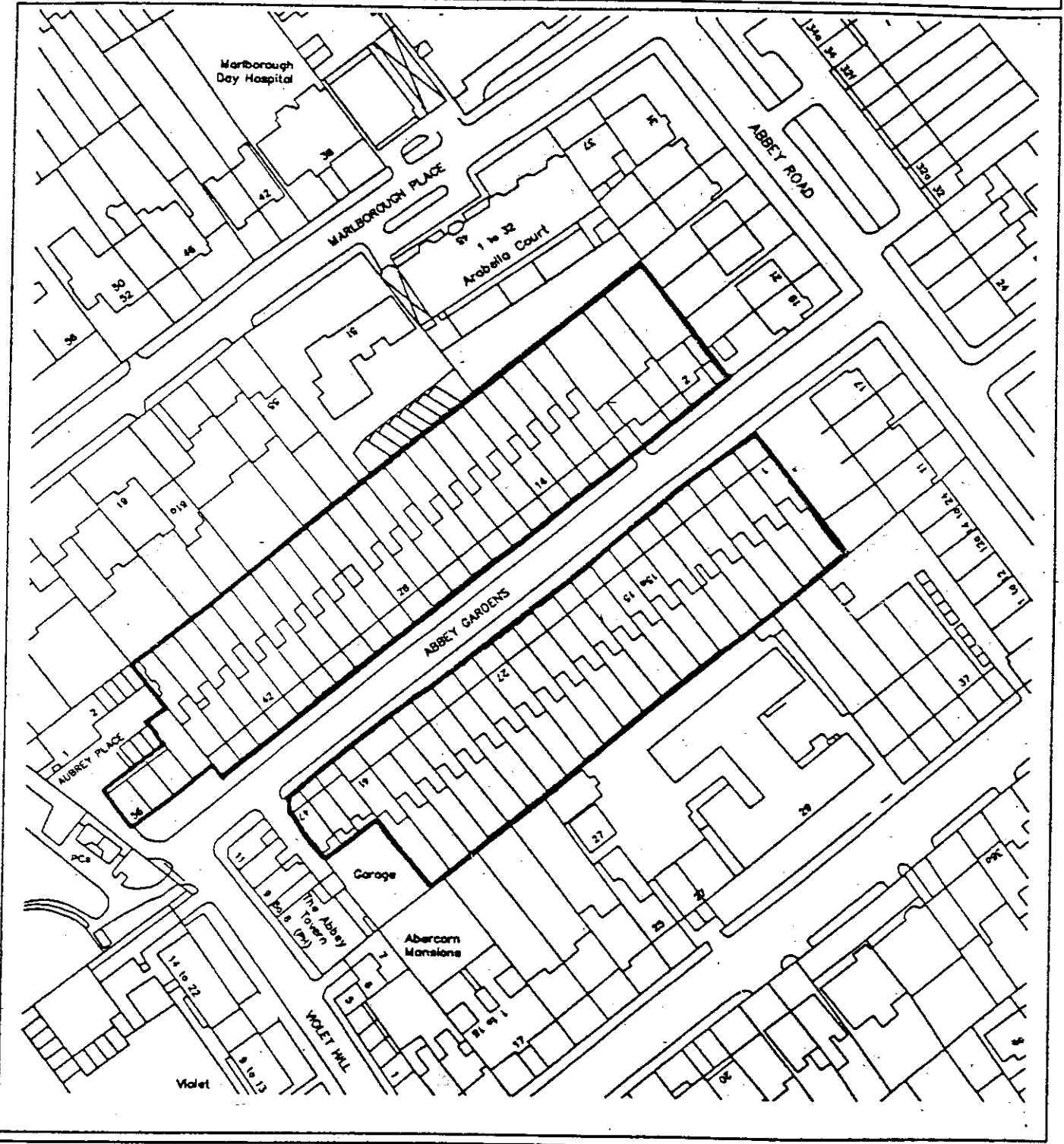

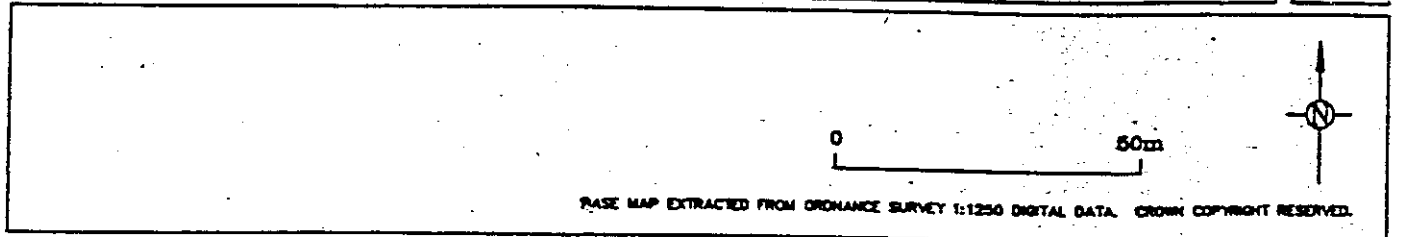
