## Addendum to Schedule of Changes to the Policies Map (I)

## 1 Introduction

The Schedule of Changes to the Policies Map (March 2024) (see document CORE\_004) summarises the proposed changes to Westminster's Policies Map for the partial revision to Westminster's City Plan. The statement accompanied the Regulation 19 Publication Draft City Plan (document CORE\_001) and its associated Regulation 19 Draft Policies Map (see document CORE\_003).

In November 2024, the council has submitted the City Plan Partial Review to the Secretary of State for independent examination. The draft Plan has been submitted alongside a series of proposed modifications – these has been logged in a Schedule of proposed Modifications (see document CORE\_002). Some proposed modifications affect spatial designations: this document has therefore been produced to keep a record of all the proposed changes to spatial designations and the Policies Map that the council believes need to be made alongside any modifications to the Plan. A Submission Policies Map (see document CORE\_005) has also been submitted to reflect this.

The Schedule of Changes to the Policies Map (March 2024), remains the core document explaining the main changes to the adopted Policies Map. This document only discusses changes to spatial designations that are being proposed at submission stage. If the council proposed any further changes through the Examination process, a new Addendum and Draft Policies Map will be published.

## 2 Overview of changes to Westminster's spatial designations and Policies Map – submission stage

This section presents an overview of all the proposed changes to spatial designations and the Policies Map. Modifications proposed at submission stage have 'S' at the start of their reference.

This reflects similar amendments to Figures 19 and 20 from the Regulation 19 Draft City Plan (see modifications S/10/11 and S/10/12).
