# **Key Topics:**

- Introduction: Henry Roffey introduced the resident forum and Lareen the nominated resident Chair. Housekeeping rules were mentioned, highlighting the importance of adhering to the agenda and encouraged participation and discussion within the time limits, to ensure a focused and effective conversation.
- Housing service update: Sarah Warman gave an update on the housing service, confirming the conclusion of the appointment process for the Chief Repairs Officer. In addition, the new Chief Surveyor was introduced, bringing experience from one of the





country's largest housing providers. An update was provided for the repairs policy consultation, which received over 3000 responses. We are currently in the analysis phase with policy decisions and circulation to follow post-election. The leasehold Charter consultation concluded with a good response rate, and the leasehold conference is scheduled for July 20th, with the senior leadership team planning to attend and build on the previous year's success.

- Joint Housing Anti-Social Behaviour (ASB) and Public Protection & Licensing (PPL) ASB update: Mark Wiltshire, Rochelle Largan & Anna Tregenza explained the roles and responsibilities of the Public Protection and Licencing Team and the Housing ASB Team, and how they work together to tackle ASB issues across the borough. It was noted that this is a collaborative effort focusing on a whole council response to address residents' quality of life and safety concerns comprehensively, with the integrated approach explained.
- Police Service Update: Superintendent Beth Pirie gave an overview of policing in Westminster and described the process of how they respond and triage cases. She also explained how the Met Police work in partnership with the Council and other agencies to address crime and ASB. The importance of reporting incidents was discussed. A resident said that it had to be easy to make a report or people would not do this. Beth Pirie mentioned that the most complained about issues are prostitution and drugs, but these are very under reported. She strongly encouraged residents to make reports and suggested the use of online reporting as a convenient option for some https://www.met.police.uk/tua/tell-us-about/soh/seen-orheard/. - Neighbourhood watch update: Imaan Williams (Chair of the City of Westminster Neighbourhood Watch Association) shared some of the activities of her neighbourhood watch group, as well as sharing examples of collaboration with other neighbourhood watches in the borough.
