TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT

ORDERS 1977-1981

WHEREAS the Council of the City of Westminster being the appropriate local planning authority within the meaning of article 4 of the Town and Country Planning General Development Orders 1977-1981 are satisfied that it is expedient that development of the description set out in the Schedule hereto should not be carried out on land at 6-10 (consecutive) Moncorvo Close, Ennismore Gardens SW7 in the said City being the land shown edged with a thick black line on the plan annexed hereto unless permission therefor is granted on application made under the Town and Country Planning General Development Orders 1977-1981

NOW THEREFORE the said Council in pursuance of the powers conferred upon them by article 4 of the Town and Country Planning General Development Orders 1977-1981 hereby direct

- (1) that the permission granted by article 3 of the said Orders shall not apply to development on the said land of the description set out in the Schedule hereto and
- (2) that the Direction dated 2nd August 1983 relating to 7 Moncorvo Close be cancelled

SCHEDULE


I The enlargement, improvement or other alterations of the dwellinghouses on the said land in so far as such enlargement, improvement or other alterations affect the rear elevations of the dwellinghouses being development comprised within Class I:1 referred to in Schedule 1 to the Town and Country Planning General Development Orders 1977 to 1981

II The erection construction or placing, and the maintenance, improvement or other alteration, within the curtilages of the dwellinghouses on the said land of any building or enclosure required for a purpose incidental to the enjoyment of the dwellinghouses as such being development comprised within Class I:3 referred to in Schedule 1 to the Town and Country Planning General Development Orders 1977 to 1981

and not being development comprised within any other Class


