1. ELECTION

An Election is to be held for a Member of Parliament for the above Constituency.

2. REGISTERING TO VOTE.

The deadline for receiving applications for registration - not later than **midnight** on **TUESDAY 18 JUNE 2024**.

3. NOMINATION PAPERS

Nomination Papers may be obtained from the offices of the Acting Returning Officer, Electoral Services, 14th Floor, Westminster City Hall, 64 Victoria Street, London, SW1E 6QP, on Monday to Friday, between the hours of 10am and 4pm, who will at the request of any elector for the constituency prepare a nomination paper for signature.

4. DELIVERY OF THE NOMINATION PAPERS

Nomination Papers must be delivered to the Acting Returning Officer, Electoral Services, 14th Floor, Westminster City Hall, 64 Victoria Street, London, SW1E 6QP, on any day after the date of this notice, on Monday to Friday between the hours of 10am and 4pm, but not later than **4pm on FRIDAY 7 JUNE 2024**. The £500 deposit can be paid by cash (British pounds only) or by means of a banker's draft, made payable to Westminster City Council, from a drawer which carries on business as a banker in the United Kingdom.

5. POLL

If the poll is contested, a poll will take place on **THURSDAY 4 JULY 2024**

The hours of poll will be 7am to 10pm.

6. ABSENT VOTES AND VOTER AUTHORITY CERTIFICATES

- (1) Applications to vote by post or to change existing postal or proxy arrangements must reach the relevant Electoral Registration Officer ****by 5pm Wednesday 19 JUNE 2024**. Applications can be made online at www.gov.uk/apply-postal-vote and www.gov.uk/apply-proxy-vote
- (2) Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer^{**} by 5pm on **Wednesday 26 JUNE 2024**. Applications can be made online: www.gov.uk/apply-for-photo-id-to-vote
- (3) New applications to vote by proxy must reach the relevant Electoral Registration Officer **** by 5pm Wednesday 26 JUNE 2024**. Some applications can be made online at www.gov.uk/apply-proxy-vote
- (4) Applications to vote by emergency proxy at this election on the grounds of physical incapacity; for work/service reasons; or photo ID is lost/ stolen/ damaged/ or voter ID not received, reach the relevant Electoral Registration Officer **** by 5pm on Thursday 4 JULY 2024**
