**VINCENT SQUARE WARD**

1. **ONE COUNCILLOR** is to be elected.
2. **REGISTERING TO VOTE.** The deadline for receiving applications for registration- not later than midnight on Tuesday 11 February 2025
3. **NOMINATION PAPERS** may be obtained from the offices of the Returning Officer, Electoral Services, 14<sup>TH</sup> Floor, Westminster City Hall, 64 Victoria Street, London, SW1E 6QP on Monday to Friday 9am to 5pm, who will at the request of any elector for the ward prepare a nomination paper for signature.
4. **DELIVERY OF THE NOMINATION PAPERS** must be made to the Returning Officer, Electoral Services, 14<sup>TH</sup> Floor, Westminster City Hall, 64 Victoria Street, London, SW1E 6QP, on any working day from the date of this notice, from 9am to 5pm, but not later than 4pm on Friday 31 January 2025.
5. **POLL.** If the election is contested, then a poll will take place on Thursday 27 February 2025. The hours of poll will be 7am to 10pm.
6. **ABSENT VOTES AND VOTER AUTHORITY CERTIFICATES**
  - (1) Applications to vote by post or to change existing postal or proxy arrangements must reach the Electoral Registration Officer by **5pm on WEDNESDAY 12 FEBRUARY 2025**.   - (2) Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by 5pm on **WEDNESDAY 19 FEBRUARY 2025** Applications can be made online: [www.gov.uk/apply-for-photo-id-to-vote](http://www.gov.uk/apply-for-photo-id-to-vote)
  - (3) New applications to vote by proxy must reach the Electoral Registration Officer by **5pm on WEDNESDAY 19 FEBRUARY 2025**. Some applications can be made online at [www.gov.uk/apply-proxy-vote](http://www.gov.uk/apply-proxy-vote)
  - (4) Applications to vote by emergency proxy at this election on the grounds of physical incapacity; for work/service reasons; or photo ID is lost/ stolen/ damaged/ or voter ID not received, must reach the Electoral Registration Officer by **5pm on THURSDAY 27 FEBRUARY 2025**
